

HACETTEPE UNIVERSITY 2018-2019 ACADEMIC YEAR

STIPULATIONS AND INSTRUCTIONS FOR INTERNATIONAL STUDENTS

4. One-year preparatory class is applicable upon request of the student, within the quotas specified (regardless of quotas, for some universities). Duration of the preparatory class is not included to the years displayed in the education period column.

11. In accordance with the law on Pharmacy and Pharmacists, and with the provisions of the relevant Regulation, those who are visually disabled or have a chronic disease impeding the practice of the profession cannot perform the profession of pharmacy.

14. Firm use of hands and fingers is of great importance for the successful fulfillment of the program

17. Students who fail to complete the preparatory class in two years are dismissed from the program. Those who have been dismissed may register for an equivalent program with a medium of instruction in Turkish, within their higher education institutions.

21. A one-year English Preparatory Class is compulsory. Those who pass the proficiency test conducted at the end of the program are directly registered to the first year of department. English Preparatory Class is not included in the education period column. Those; (a) who submit a document stating that they obtained a passing score in a national and/or international foreign language proficiency test; or (b) who pass the English proficiency test conducted at the beginning of the academic year, are directly registered to the first year of department. Students are applied the "Regulation on the Rules to be Followed in Foreign Language Teaching and Language Immersion in Higher Education Institutions".

28. Medium of instruction is in English.

38. Students of this program are obliged to wear uniform in applied courses as required.

51. Students must take two separate exemption tests being in English and German languages. Students who pass both of them may directly commence their undergraduate studies. Those who fail either of the tests must study one year of English or German Preparatory Class. Students who fail both of tests are required to study one year of English and one year of German Preparatory Classes.

86. Medium of instruction is at least 30% English.

87. Students must obtain a health report issued by a committee, from a hospital appointed by the University or which is fully-equipped, clarifying that the person has no visual (including color-blindness), audial, speech, orthopedic and/or mental impairments to impede the practice of profession.

124. Medium of instruction is German

125. A one-year German Preparatory Class is compulsory. Students who pass the language proficiency test at the end of the program are directly registered to the first year of department. German preparatory class is not included in the education period column. Those (a) who submit a document stating that they obtained a passing score in a national and/or international foreign language

proficiency test; or (b) who pass the German proficiency test conducted at the beginning of the academic year, are directly registered to the first year of department. Students are applied the "Regulation on the Rules to be Followed in Foreign Language Teaching and Language Immersion in Higher Education Institutions"

128. Medium of instruction is French.

129. A one-year French Preparatory Class is compulsory. Students who pass the proficiency test at the end of the program are directly registered to the first year of department. French preparatory class is not included in the education period column. Those (a) who submit a document stating that they obtained a passing score in a national and/or international foreign language proficiency test; or (b) who pass the French proficiency test conducted at the beginning of the academic year, are directly registered to the first year of department. Students are applied the "Regulation on the Rules to be Followed in Foreign Language Teaching and Language Immersion in Higher Education Institutions".

233. Students of this program are required obtain a report from state or university hospitals, stating that they are physically and mentally entitled to acquire driving license (Height and weight of the student must be specified in the report). The students must also have passed the age of 17 by the time they register university since they are supposed to perform driving in the 2nd year. Also, male students must not be less than 165 cm in height; while the limit is 160 cm for female students. Weight of students can be 5 units more than the last two digits of height (as in centimeters) or 15 units less maximum. They must be physically capable of carrying a patient in a stretcher in a team of two during necessary actions.

249. For a bilingual diploma in German Translation and Interpreting Program, students who submit a proficiency certificate in English or French languages are applied a bilingual program in the 3rd and 4th years, and are awarded a bilingual diploma in Translation and Interpreting. In French Translation and Interpreting Program, students who submit a proficiency certificate in English or German languages are applied a bilingual program in the 3rd and 4th years, and are awarded a bilingual diploma in Translation and Interpreting. 274. Male students of this program must not be less than 165 cm in height; while the limit is 160 cm for female students. Weight of students can be 5 units more than the last two digits of height (as in centimeters) or 15 units less maximum. They must be physically capable of carrying a patient in a stretcher in a team of two during necessary actions.

723. Since this program is mostly based on laboratory classes, students with unrecoverable visual impairments or extensive physical disabilities may have difficulties in following the classes.

774. Students willing to study this program must not have visual or audial disabilities.

834. Students of this program may apply for Hacettepe University Faculty of Medicine Doctor of Medicine Joint Program, as long as they meet the criteria specified in the Regulation published on the Official Gazette on 19/03/2008 no. 26821).Candidates who are admitted to the program through interview and application assessment are transferred to a double-degree (Doctor of Medicine MD and Doctor of Philosophy PhD) Joint Program of Doctor of Medicine and Philosophy. Double-degree program extends the education period for two years (four semesters).
